

\$25 TIOmarkets TRADING BONUS TERMS & CONDITIONS

1. This Promotion will run until 31st August 2022.
2. Only clients of the TIOmarkets St Vincent's entity are eligible to benefit from this Promotion.
3. The Promotion applies to new clients only or to existing clients who will make their 1st-time deposit during the Promotional period. Clients who have already deposited are not eligible for this promotion. 2nd-time deposits and or any subsequent deposits will not be considered for this Promotion.
4. The minimum deposit to be eligible for this Promotion is 50 USD or currency equivalent. There is no maximum deposit amount.
5. Deposits across all accepted currencies will be eligible for this promotion, except for deposits by TIOx. Any deposits by TIOx will not be eligible to receive the additional 25 USD in trading funds.
