



Refer a Friend Promotion Terms & Conditions

SUMMARY

Clients of TIOMarkets who refer traders to the company are eligible to receive \$50 fully withdrawable trading funds for each friend referred.

MECHANIC

1. Client should be a verified TIOMarkets client, completing the registration form, verifying their email address, and completing their client profile in order to be a KYC-verified client.
2. Client should visit the REFER A FRIEND tab from within their client portal to obtain their personalised promo code, FRIEND****
3. The client can encourage friends to register using their promo code, by sharing that promo code on social media, by sms or email or any other suitable method.
4. The friend should become a fully registered client of TIOMarkets and enter the personalised promo code at the point of placing their first deposit of minimum 100 USD (or equivalent) within the client portal.
5. The client will obtain \$50 withdrawable trading funds into their account within 1 business day

ADDITIONAL TERMS

6. This Promotion will run until 31 July 2021.
7. Client can benefit from one payment of \$50 per friend referred. Repeat deposits from referred friends do not qualify.
8. The client will not receive the referral fee for referrals who have signed up with TIOMarkets prior to the launch of this campaign (on 17 May 2021)
9. The \$50 referral fee is awarded for qualified first time deposits only and not on subsequent deposits.
10. Friends who register for PAMM, DEMO or TIOprime accounts do not qualify for this promotion
11. The Promotion applies to any new or existing client who can refer friends to TIOMarkets after the date of promotion launch
12. Friends entering false or fake promo codes will be disqualified from this promo
13. Referrals who deem to be abusing the terms and conditions of this promotion or of the TIOMarkets general terms of trading will be disqualified from this promotion and the original introducer will not received his or her referral fee
14. The \$50 trading funds awarded for qualified referrals can also be used for trading if the client chooses
15. The introducer does not necessarily have to have made a first deposit in order to benefit from this promotion



16. The referral does not necessarily have to have made a first trade in order for the introducer to receive his / her referral fee
17. Introducing Brokers (IBs) of TIOmarkets who are registered as partners with the company are not eligible to participate in this refer a friend Promotion
18. Referrals of existing TIOmarkets partners are eligible to refer their own friends to the company in order to receive the refer a friend bonus funds
19. In the case that a client has been referred by more than one person, the first introducer will be credited for the introduction, unless advised otherwise by TIOmarkets management.
20. Any changes to this Promotion shall be at the discretion of TIOmarkets without any prior notice.
21. TIOmarkets has the right to withdraw without prior notice the Promotion or profit gained if: a) a breach of these Terms and Conditions occurs; b) Upon expiration of the Promotion, the trading terms are not satisfied; c) The Company has reasonable grounds to believe a misuse of the Promotion; d) Client attempts to withdraw any part of the Promotion before satisfying the Trading Terms. e) TIOmarkets has reasonable suspicion that the Client has already or intends to takes advantage of the Promotion.
22. TIOmarkets will not be liable for any margin call or losses that you may suffer, including but not limited to losses due to Stop-out.
23. TIOmarkets reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel or terminate the Promotion, or any aspect of the Promotion, at any time and without any prior notice.
24. Under no circumstances shall TIOmarkets be liable for any consequences of any alteration, amendment, suspension, cancelation or termination of the Promotion.
25. Any indication or suspicion of fraud, manipulation, cash-back arbitrage, or other forms of deceitful or fraudulent activity in a client's account with TIOmarkets or otherwise related or connected to the Promotion will nullify any and all transactions carried and/or profits or losses garnered therein.

TIOmarkets reserves the right, at its sole discretion, to disqualify any individual that misuses or attempts to misuse the Promotion, or breaches the present Terms and Conditions and/or any of TIOmarkets' Business Terms and to cancel all orders and annul all profits of such client. In these circumstances, TIOmarkets shall not be liable for any consequences of the Promotion cancelation.

In the event of any dispute or misinterpretation of the above applicable Terms and Conditions, such dispute or misinterpretation shall be resolved as TIOmarkets acting in good faith and as it shall, in its sole and absolute discretion, deem fit and proper. TIOmarkets decision shall be final and binding.
28. By participating in the Promotion, the Client acknowledges that they have read and agreed to be bound by these terms and conditions of the Promotion together with TIOmarkets' terms and conditions of trading.



29. Notwithstanding the translated language of this document, the English wording shall be the binding version in the event of any discrepancy between the two languages.
30. Any client or any of his/her referrals must be registered under the Saint Vincent and Grenadines entity of TIOmarkets in order to be eligible for this Promotion
31. Clients or friends who are registered under the UK entity of TIOmarkets are not eligible to participate in this Promotion.
